NOTICE TO CAMERON COUNTY SUMMER RV GUESTS REGARDING RESERVATIONS FOR ISLA BLANCA PARK AND ANDY BOWIE PARK ON JANUARY 15, 2018

The Cameron County Parks & Recreation Department would like to remind summer guests that we will begin accepting reservations for Isla Blanca Park and Andy Bowie Park on January 15, 2018 at 8:00 am. Reservations will be accepted in person and via telephone. We anticipate a large turn out and want to provide some information we think will help minimize delays during the reservation process. Please take the following guidelines into consideration when making a reservation in person:

- Reservations will be accepted from 8:00 am until 8:00 pm on Monday, January 15, 2018. Reservations for any remaining sites will resume the following day at 8:00 am.
- Patrons will need to obtain a numbered ticket from staff. Tickets will be issued starting at 7:00 a.m. Individuals will be called by their ticket number when staff is ready to serve them.
- A parking area has been designated for all guests wishing to make summer reservations. The parking area will open on January 15, 2018 at 6:00 a.m., and can be accessed through the main entrance of the Sea Ranch Marina parking lot (south of the Isla Blanca Park Main Office). It is extremely important that guest park only within the designated parking area.
- The parking areas located directly outside the Registration office will be designated for RVs checking in or out on that particular day. Non-handicap parking spaces in these areas will be limited to a 30 minute parking time limit.
- Individuals seeking to gain an advantage by arriving the day or night before will NOT be permitted to camp overnight in parking lots, side streets, etc. Park Rangers will be on patrol and enforcing these guidelines.
- A valid TX Driver's License or ID is required – Only one reservation per individual. Reservations cannot be made for others. Anyone found violating the reservation


procedures in the Parks Space Agreement may be subject to termination of the agreement.

- Two telephone numbers (if available) and an email (if available) will be required when making your reservation.
- 60 RV sites inside the park have been designated for daily rentals only. These sites cannot be rented for a period longer than two weeks.

We highly recommend for individuals making reservations in person or via telephone, to carefully review the Park Space Agreement prior to calling or coming in. Familiarizing oneself with the Parks Space Agreement will help minimize questions and expedite reservations. In order for registration clerks to efficiently expedite calls, we kindly ask for callers to be prepared with the required information.
